NOISE FOR NOW X SEEDING SOVEREIGNTY MASK CAMPAIGN NOISE FOR NOW TEAMED UP WITH SEEDING SOVEREIGNTY TO ADDRESS THE SEVERE IMPACTS INDIGENOUS COMMUNITIES ARE FACING DUE TO THE COVID-19 PANDEMIC. 90 ARTISTS AND ENTERTAINERS WORE OUR CUSTOM-MADE MASKS ON SOCIAL MEDIA TO PROMOTE OUR GIVE-ONE/GET-ONE MASK CAMPAIGN. 12,500 MASKS WERE DONATED TO SEEDING SOVEREIGNTY FOR DISTRIBUTION TO INDIGENOUS COMMUNITY MEMBERS BY THEIR INDIGENOUS IMPACT COMMUNITY CARE INITIATIVE.
